The purpose of this Privacy Policy is to provide you with a clear explanation of when, why and how we collect and use your personal information, as well as an explanation of your statutory rights. PRIVACY POLICY:

We are committed to protecting your privacy and any personal information we collect about you. "Personal information" is personally identifiable

information such as your name, residential address and e-mail address and includes information about your products, services, subscriptions and usage and billing records. We do not capture or store credit card or payment information.

Personal Information

Personal Information under PIPEDA is any information about an identifiable individual, but does not include the name, title, business address or telephone number of an employee of an organization.

What information do we collect?

Visitor and User Information
We collect two types of information regarding our Visitors and Users:

Un-identified and non-identifiable information pertaining to a Visitor or unidentified User, which may be made available to us, or collected automatically via his/her use of the Services ("Non-personal Information"). Such Non-personal Information does not enable us to identify the Visitor or User from whom it was collected. The Non-personal Information collected by us mainly consists of technical and aggregated usage information, such as Visitors' and Users' browsing and 'click-stream' activity on the Services, session heatmaps and scrolls, non-identifying information regarding the Visitor's or User's device, operating system, internet browser, screen resolution, language and keyboard settings, internet service provider, referring/exit pages, date/time stamps, etc.

Individually identifiable information, namely information that identifies an individual or may with reasonable efforts cause the identification of an individual, or may be of private or sensitive nature ("Personal Information"). The Personal Information collected by us mainly consists of contact details (e.g., e-mail address or phone number), billing details (name, physical billing address, payment method and transaction details), which are only collected from Users with Paid Services, details regarding a browsing or usage session (IP address, Geo-location and/or device unique identifier),

details regarding connected third party accounts (such as the e-mail or username for a connected PayPal, Google or Facebook account), correspondences (including those made through or uploaded to our Services), and any other Personal Information provided to us by Visitors and/or Users through their access to and/or use of the Services. For the avoidance of doubt, any Non-personal Information that is connected or linked to Personal Information (for example, in order to improve the Services we offer) is deemed and treated by us as Personal Information, as long as such connection or linkage exists.

We do not collect or hold any personal payment data as payment transactions occur securely via PayPal or email transfer directly between customers purchasing our services.

We collect two types of information: Personal Information (which could be used to uniquely identify an individual) and Non-personal Information (which is non-identifying).

We collect such information regarding our users and visitors, our users' users, job applicant and anyone else who may provide it to us.

How do we collect such information?

There are two main methods we use:

We collect information through your use of the website through completing online form inquiries or by emailing us with your information. When you visit or use our Services, including when you browse the Website and/or Subscribe to our Blog or Website, we are aware of it and may occasionally gather, collect and record such uses, sessions and related information, independently or with the help of third-party services, including through the use of "cookies" and other tracking technologies, as further detailed.

We collect information which you provide us voluntarily. For example, we collect the Personal Information you provide us when you inquire about booking our Services; when you sign in to our Services via third party services such as Facebook or Google; when you place purchases; when you submit or upload such Personal Information as you use any of our

Services; and/or when you contact us directly by any communication channel (e.g., online form, emails).

We also collect information from third party sources as described in Section 8 below.

Why do we collect such information?

We collect such Non-personal and Personal Information for the following purposes:

To provide and operate the Services;

To further develop, customize and improve our Services, based on Visitors' and Users' common or personal preferences, experiences and difficulties; To provide you with a quote for your Glamping Packages and ensure we are creating an unique experience that meets your individual criteria.

To be able to contact our Visitors and Users with general or personalized service-related notices and promotional messages;

To comply with any applicable laws and regulations.

We will only use your Personal Information for the purposes of creating a customized Glamping package for your event or reservation of facilitate delivery to you of a purchase made at East Coast Glamping:

our use of your Personal Information is necessary to perform a contract or take steps to enter into a contract with you, or

our use of your Personal Information is necessary to comply with a relevant legal or regulatory obligation that we have, or

our use of your Personal Information is necessary to support legitimate interests that we have as a business (for example, to maintain and improve our Services by identifying user trends and the effectiveness of East Coast Glamping campaigns), provided it is conducted at all times in a way that is proportionate, and that respects your privacy rights.

Our Services are not permitted to children under 18 years of age. No one under age 18 should provide any Personal Information to us through any of our Services. We do not knowingly collect Personal Information from children under 18. Parents and guardians should supervise their children's activities at all times.

We also collect and use information in order to contact our visitors, users and job applicants, and in order to comply with the laws applicable to us.

Where do we store your information?

East Coast Glamping Visitors', East Coast Glamping Users' and Users-of-Users' Personal Information may be maintained, processed and stored by East Coast Glamping. This information is stored securely and locally.

East Coast Glamping Jobs Applicants Information will be maintained, processed and stored offline and as necessary, in secured cloud storage provided by our Third Party Services.

Why do we collect Personal Information?

Information You Provide To Us. The Website provides various places for users to provide information. We collect information that users provide by filling out forms on the Website, communicating with us via contact forms, responding to surveys, search queries on our search feature, providing comments or other feedback, and providing information when ordering a product or service via the Website.

We use information you provide to us to deliver the requested product and/or service, to improve our overall performance, and to provide you with offers, promotions, and information.

The type of personal information we may or may not collect includes: name, address, country of origin for travel, names of travel companions and ages and contact information. We ask for age-related information to custom-furnish every tent uniquelly.

The COMPANY may collect Personal Information about you and use it indefinitely for the following reasons to provide products and services to you: to inform you of changes and other relevant information pertaining to your purchase, to bill you when you make a purchase from us, or to improve our service offerings. East Coast Glamping takes your privacy very seriously and WILL NEVER sell or rent any Personal Information it collects. Should you wish to access or discuss the nature or use of your Personal Information as collected by East Coast Glamping, or update or request removal of that information, this is absolutely your right, and please contact us at cyn@eastcoastglamping.ca to do so. Of course, you can also unsubscribe from any newsletter or other East Coast Glamping mailing list at any time – if you have trouble with this, again, just let us know!

The Company collects your information in order to record and support your participation in the activities you select. If you register to download a PDF or resources, sign up for our newsletter, and/or purchase a product from us, we collect your information. We use this information to track your preferences and to keep you informed about the products and services you have selected to receive and any related products and/or services.

How do we use non-personal information?

Our site's operating system may automatically record some general information about your visit, such as:

- The country the search came from;
- The Internet domain for your Internet service provider, such as 'company.com' or
- 'service.ca' and the IP address of the computer accessing the website, such as 'ppp-55;
- The type of browser (such as 'Safari version x' or 'Internet Explorer version x') you are using;
- The type of operating system you are using (such as Macintosh, Unix, or Windows);
- The date and time you visit our site and the web pages that you visit on our site, along with the address of the previous website you were visiting, if you linked to us from another web site.

We use this information for statistical analysis to help us make our site more useful to users. We may disclose this non-personal information to third parties such as suppliers, clients or advertisers and/or use it for auditing purposes. This tracking

system does not record personal information about individuals or link this information to any personal data collected.

We may use 'cookies' that identify you as a return visitor. A cookie is a piece of data that a website can send to your browser, which may then store the cookie on your hard drive. So, when you come back to visit us again, we can tailor information to suit your individual preferences. The goal is to save you time and provide you with a more meaningful visit and to measure website activity. Cookies do not contain any personally identifying information. Browsers allow you to disable cookie collection if you wish, or inform you when a cookie is being stored on your hard drive.

Email Policies and What about spam?

We are committed to keeping your e-mail address confidential. We do not sell, rent, or lease our subscription lists to third parties, and will not disclose your email address to any third parties except as required by law.

You will not receive marketing email from Simply Good Form Consultancy unless you have consented to receive it.

From time to time we may use email as a way to keep in touch with our existing customers and other interested individuals. However, we do not send 'spam' (unsolicited marketing email).

If you agree to receive email communications from us, every email message we send you will include an email address to which you can respond. If at any time you decide you do not want to receive marketing email from us, simply let us know and we will remove your name and email address from our marketing lists. We will do the same with your mailing address and telephone number on request.
